Please bring a lawn chair as we will be socially distancing in and around the pavilion. There are 10 picnic tables where some people can spread out facing the front of the pavilion. Others can sit just outside the pavilion in lawn chairs. If you wish to feel more comfortable, please also plan on bringing your face mask so you can feel safer when near others. There will be no community snacks and drinks provided due to concerns about food sharing.

To get to the park, take M-22 north as if you were heading toward Suttons Bay. Continue on M-22 past the M-72 turnoff (Tom's West Bay) to the next light, which is Cherry Bend Road. Turn left and then go straight until the road makes a 90 degree turn to the right. Shortly after the turn you will begin to see the park on your left. Go to the end of the park and turn left on Lincoln Rd. The entrance will be about  $\frac{1}{4}$  mile on your left and you will see the pavilion. If you want to put the address in your GPS or mapping app, use 10090 E Lincoln Rd, which is the township hall just across the parking lot from the pavilion.
